SOUTH DAKOTA CAMPAIGN FINANCE CONTRIBUTION LIMITS

NO CANDIDATE OR POLITICAL COMMITTEE MAY:

- Accept any contribution from any state, state agency, political subdivision of the state, foreign government, federal agency, or the federal government. (12-27-21)
- Give or accept a contribution unless the name, mailing address, city & state of the contributor is made known to the person, entity, candidate, or political committee receiving the contribution. Any contribution, money, or other thing of value received by a candidate or political committee from an unknown source shall be donated to a nonprofit charitable entity. (12-27-11)

CANDIDATE CAMPAIGN COMMITTEES: Contributions received by a candidate campaign committee may only be

used for: (1) A purpose related to a candidate's campaign;

- (2) Expenses incident to being a public official or former public official; or
- (3) Donations to any other candidate, political committee, or nonprofit charitable organization. (12-27-50)

Donated goods or services **DO COUNT** towards contribution limits. (SDCL 12-27-1 (6))

* Individual – a candidate or candidate's immediate family may give unlimited contributions

PAC – includes federal and statewide *Party – includes national, statewide, county and auxiliary

Contribution Limits Statute References: SDCL 12-27-7, 8, 9, 10 and 18.1

*Any contribution from a person who is an unemancipated **minor** shall be deducted from the total contribution permitted under this section by the unemancipated minor's custodial parent or parents. Does not apply if a minor is immediate family to the candidate.
