

Statement of Organization

SDCL 12-27-6

<u>WHO FILES:</u> New committees forming, existing committees updating information and any entity making expenditures, equal to or exceeding 50% of the entity's annual gross income, for the adoption or defeat of a ballot measure (<u>SDCL 12-27-18</u>).

<u>DEADLINE TO FILE</u>: The Treasurer for a political committee shall file a statement of organization not later than **15 days after** the date upon which the committee made contributions, received contributions, or paid expenses in excess of \$500.00. However, if such activity falls within 30 days of any statewide election, the statement of organization shall be filed within 48 hours. A candidate shall file a statement of organization for a candidate campaign committee not later than **15 days after becoming a** candidate (SDCL <u>12-27-3</u>; <u>12-27-22.1</u>). The treasurer of a political committee shall file an updated statement of organization not later than fifteen days after ANY change in the information contained on this statement.

ONLY FILE WITH: Committee types below are required to file with The South Dakota Secretary of State's office.
