Please let this serve as Big Brothers Big Sisters of the Black Hills' Letter of Intent to conduct a raffle called "The BIG Golf Ball Drop". The event is scheduled for August 18, 2011 at Memorial Park, Rapid City, SD. Up to 5000 numbered golf balls will be dropped from a crane onto a target area set up in the park.
