for a Certificate of Registration pursuant to the provisions of SDCL 43-27-1, has been received and duly filed for record.

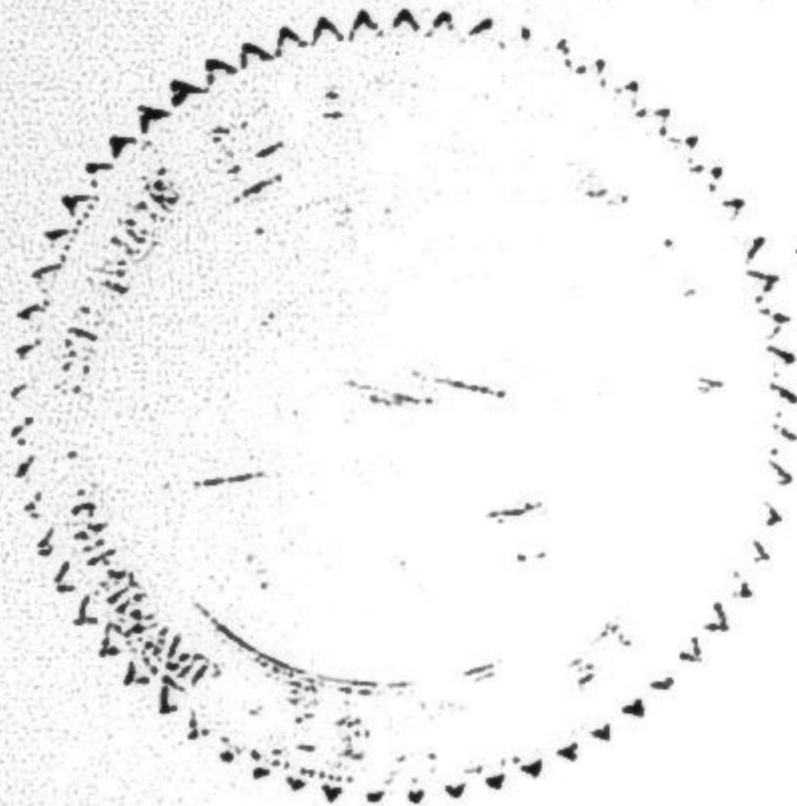
