Moved by Viken and seconded to approve the changes to ARSD 5:02:05:02 and 5:02:05:02.01 to include additional information regarding voting rights of persons convicted of a disqualifying felony and to include the phone number of the state's attorney in the publication of the instructions to the voters. Motion passed.

Moved by Madsen and seconded to approve the changes to ARSD 5:02:06:01 to clarify the format of the language for the Water Development District and Heartland Consumer Power District director races on the general election ballot. Motion passed.

Moved by Madsen and seconded to approve the changes ARSD 5:02:06:10 to clarify the format of the language for the Water Development District and Heartland Consumer Power District director races on the primary election ballot. Motion passed.
