

REFERENDUM PETITION

WE, THE UNDERSIGNED qualified voters of the state of South Dakota, petition that the following law, as enacted by the Legislature of the state of South Dakota, be submitted to the voters of the state of South Dakota at the general election on November 7, 2006, for their approval or rejection pursuant to the Constitution of the state of South Dakota.

HB 1215: ABORTION—CRIMES AND OFFENSES—CONTRACEPTIVES.

An act to establish certain legislative findings, to reinstate the prohibition against certain acts causing the termination of an unborn human life, to prescribe a penalty therefore, and to provide for the implementation of such provisions under certain circumstances. Initially passed by the House on February 9, 2006; passed by the Senate February 22, 2006; final passage by the House which concurred with Senate amendments on February 24, 2006, and Approved by the Governor on March 6, 2006.
