**INFORMATION FOR BALLOT MEASURE SPONSORS**  
**PROOF OF CIRCULATOR RESIDENCY**

The following information must be provided regarding **EACH** petition circulator, pursuant to [SDCL 2-1-1.4](#) which was passed by the SD Legislature during the 2018 Legislative Session.

This Proof of Circulator Residency is to be filed by the Sponsor, **WITH THE COMPLETED PETITIONS**, pursuant to SDCL [2-1-1.1](#) and [1.2](#).

The information provided are factors in determining residency but are not determinative. The contents provided to the secretary of state shall be held confidential by the secretary of state and may be released only to an interested person for purposes of [SDCL 2-1-18](#) and to the attorney general.

Failure to substantially comply with the provisions of this section shall disqualify the petitions from a petition circulator not in substantial compliance with this section from being considered.
