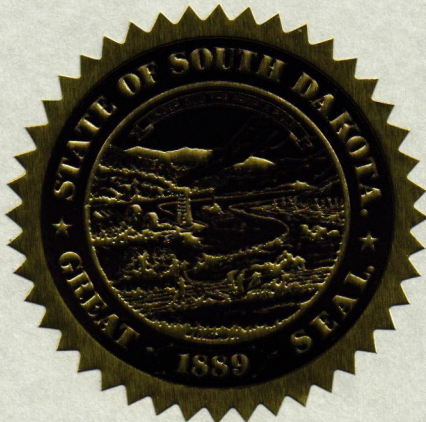





CERTIFICATE OF VOTE

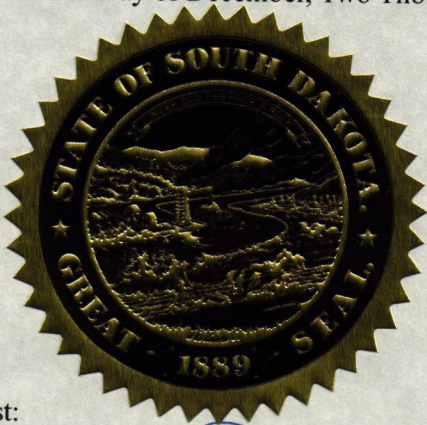
We, the undersigned, Electors of President and Vice President of the United States of America for the respective terms of President and Vice President, beginning on the Twentieth Day of January, Two Thousand and Twenty-Five, being Electors duly and legally elected and qualified in and for the State of South Dakota, as appears by the annexed Certificate of Ascertainment of Election made certified, and delivered to us by the Governor of said State and having the signature of the Governor of said State, affixed thereto, having met and convened in the state Capitol, in the city of Pierre, in the state of South Dakota, in pursuance of the Statutes of the State of South Dakota and of the United States on the first Tuesday after the second Wednesday in December, being the Seventeenth day of December, Two Thousand and Twenty-Four, do hereby certify that being so assembled and duly organized, we proceeded to vote by ballot, and balloted first for such President and then for such Vice President, by distinct ballots.
