The following is a brief description of the proceedings of this recount board:

The Recount procedure outlined in ARSD 5:02:09:05 was used. Ballots were recounted using the AIS 550 scanner.

The Recount Board examined all correctly printed precinct and absentee ballots, setting aside any ballots which they felt might not be correctly read by the scanner and ran these ballots through the scanner separately. Otherwise, these ballots were counted, by scanner.

Ballots in which the District 11 races were incorrectly printed on District 10 ballot stock were counted by hand. There were 67 such ballots in precinct 1-7 and 182 in precinct 1-8.

There were no disputed ballots.
