




South Dakota New Entity Filings 1980-2023

South Dakota Trademarks 2023 Q1 - 2024 Q3



Quarterly from 2019-2024










YOUTH SPORTS

In the town of Mitchell, youth sports are more than just games—they are a major economic driver for the community. Aaron Heib, a resident and sports enthusiast, has watched as youth tournaments, especially those for kids aged 14 and under, bring families and fans from nearby towns. These events pack hotels, boost business for local restaurants, and keep convenience stores bustling with activity. "Multi-day tournaments, especially, have a huge impact," Heib explains.

Basketball generates the most revenue, followed by baseball, hockey, and wrestling, according to Heib. With high attendance and community pride, these sports create a steady stream of business for local establishments. Retail shops see spikes in sales, and restaurants are often packed on game nights. Yet, despite all the excitement, Heib acknowledges the financial strain these sports can place on families, especially when it comes to equipment, travel, and tournament fees. For some families, high costs may limit participation, making household income a factor in youth sports involvement.

Sports events have become a reliable economic driver for Mitchell's businesses. From convenience stores to diners, everyone prepares for busy weekends when the town's venues are filled with cheering crowds. Youth sports have also grown in popularity over the past few years, as improved technology and facilities make the games more exciting and accessible. Heib believes Mitchell's dedication to sports not only boosts the economy but also strengthens the community, making each tournament a win for the entire town.






This comparison highlights the seasonal impact on tourism sales, showing a decline in key categories like accommodations and services between June 2023 and June 2024.


Total Dollar Sales










COST OF LIVING STORY

Stuart Keenan, a business professor at Dakota Wesleyan University, offers unique personal insights into the cost-of-living realities of moving to Mitchell, SD. Examining Keenan's journey reveals key economic factors affecting daily life in Mitchell, including grocery prices and housing costs. His experiences highlight both the benefits and limitations of Mitchell's cost of living.

Keenan moved to Mitchell, SD, after accepting a job as the registrar at Dakota Wesleyan University, in 2020. He eventually transitioned to a position in the business department. Relocating from Michigan with his family, he found that while larger expenses, such as housing, were less costly, day-to-day costs were often higher. One of the most significant cost increases Keenan noticed was in grocery prices. He stated, "Our grocery prices almost doubled between Michigan and here." With four children and a single-family income, his family became increasingly aware of these price increases. They adapted by making lifestyle changes, such as baking their own sandwich bread and planning their dining out more carefully.

Keenan also noted his good fortune in the housing market. When he moved, his family was able to purchase a home at a lower price than what they sold their house for in Michigan. He attributes this advantage to a steadily increasing housing market in Mitchell. However, he observed that the market lacks options for first-time homebuyers and retirees. Keenan believes that building smaller, more affordable homes could help stimulate the housing market and make housing more accessible.

Gas prices in Mitchell have generally remained close to national averages despite fluctuations. For Keenan, transportation costs are less challenging than grocery expenses due to his five-minute commute. However, he noted that for families who need to travel frequently, shifts in gas prices might require additional budgeting considerations.


Keenan's move to Mitchell, SD, illustrates the various dynamics of the local cost of living. While his family benefited from lower housing costs, they faced higher day-to-day expenses, particularly for groceries. His story offers insights into the adaptability required for living in Mitchell and highlights the impact of local economic conditions on family life.

AVERAGE TOTAL COST OF UTILITIES PER COMMUNITY


Total Amount Spent on Utilities in 2024






Years 2019-2023












Income in the Past 12 Months (in 2022 Inflation-Adjusted Dollars)

Coverage by Age: 2022 5-Year Estimate






POVERTY STATUS (PAST 12 MONTHS)





% Below Poverty Level by Race: 2022 5-Year Estimate





HOUSING

HOUSING PROBLEM

Mitchell's population has been steadily increasing, and with that growth, the housing situation has become a central issue for the community. Terry Sabers, President of Mitchell Area Housing Inc., has played a pivotal role in making the city a more affordable place to live. In a recent conversation, Sabers explained that one of Mitchell's most pressing needs is the construction of more low-income/workforce housing.

Significant numbers of Dakota Wesleyan University and Mitchell Technical College graduates choose to remain in the area. However, many of these recent graduates face a challenge: the housing market in Mitchell is priced out of reach. According to Sabers, the solution to this issue lies in the development of approximately 20 new low-income/workforce homes each year, a plan that will continue for the foreseeable future. The initiative provides affordable housing for graduates, enabling them to establish roots in the community and contribute to the local economy.

In addition to the housing needs, Mitchell is also experiencing economic growth. A new soybean processing plant is being built on the south side of town, which is expected to create around 70 new jobs. However, Sabers pointed out that the quality of available housing is a major barrier to attracting new employees to the area. He noted that approximately one-third of homes in Mitchell require complete renovations, another third need minor repairs, and the remaining third are in satisfactory condition. For many potential employees, the housing condition is a dealbreaker, leading some to seek employment in neighboring communities where housing options are more attractive.

This issue extends beyond the soybean plant and affects businesses of all sizes in Mitchell. Without affordable and well-maintained housing options, Mitchell's ability to attract and retain talent—both from within the community and beyond—is hindered. Sabers emphasized that the city's economic expansion will be limited if housing challenges are not addressed.

To tackle this issue, Sabers has already secured two areas of land to construct new low-income/workforce housing developments. These homes, which are funded by the state of South Dakota, will cater to both young professionals just starting their careers and older residents looking to downsize. With these developments underway, Sabers is optimistic that Mitchell's low-income/workforce housing shortage will be largely alleviated upon completion.





Building permits reflect construction activity and provide insight into housing market trends in Mitchell over the past decade.






















Establishments by # of Employees





NUMBER OF BUSINESSES BY ESTABLISHMENT TYPE

















AGRICULTURAL IMPORTANCE

He is passionate about the agricultural industry, finding fulfillment in knowing that his work directly supports such an important sector. Camden appreciates the diversity within the agricultural business, recognizing that many factors influence how small agricultural businesses operate. One key lesson he has learned is the importance of being flexible with financial decisions, as the agricultural sector can be highly variable, and his work allows him to assist businesses in a variety of ways.

Importance of Harvested Acres for Small Businesses:

Harvested acres provide crucial insight into a business's performance. By understanding how much of a crop is actually harvested, businesses can plan their finances more effectively. Many small ag businesses depend on good harvests to thrive, so tracking harvested acres helps lenders and farmers anticipate revenue, manage risk, and plan for expenses. Weather, pests, and other factors can impact harvests, making this information essential for financial stability.

Key Drivers of Small Agricultural Businesses:

The most important factor driving small ag businesses is fluctuating income, which can change significantly year-to-year due to variables like weather and market conditions. A poor harvest due to drought or other factors can negatively affect a business's income. Operational expenses also play a role, as these costs can vary unpredictably, making it difficult for farmers to anticipate their financial needs.


Importance of Planted Acres for Small Businesses:

Tracking planted acres is critical for forecasting yields and managing finances. By knowing how many acres are planted, businesses can predict potential crop yields and set realistic financial expectations. This allows them to plan expenses more accurately, as input costs (e.g., seeds, fertilizer, labor) are tied to the number of acres planted. If more acres are planted but fewer are harvested, it can lead to financial shortfalls, but businesses still benefit from having an idea of planted acreage to guide their decisions.




PLANTED VS. HARVESTED ACRES

Tracking planted versus harvested acres provides essential insights into agricultural productivity and the challenges faced by South Dakota farmers.





State Production Dollars Comparision













Total Retail Sales Report for Mitchell 2021





Total Retail Sales Report for Mitchell 2023








TOTAL RETAIL SALES, 2021

Comparing Mitchell and Yankton Total Retail Sales, 2021





Seven-Year Data Estimates for Mitchell and Yankton Retail Sales, 2017-2023


